***Demand and supply theory** -How the demand and supply changes according to changes in price and other things

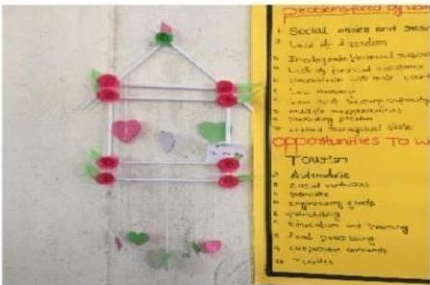
